The purpose of this modification is to:

1. Increase Target Costs, Base Fee and extend the period of performance to CLIN 0001A.

  - c. As a result of this modification CLIN 0006 funding is increased by \$91,834 from \$4,780,534 to 4,872,368.
  - d. As a result of this modification CLIN 0004A funding is decreased by \$1,188,870 from \$5,452,683 to \$4,263,813.
  
3. Extend the period of performance for CLIN 0004 and CLIN 0004A at no additional cost. CLIN 0004 period of performance end date is extended to June 19, 2009. CLIN 0004A period of performance end date is extended to June 19, 2009.

This extension supports the settlement activities of the terminated Intelligence efforts as a result of the Government's notice of termination, dated February 6, 2009.
