Boeing hereby requests a revision to the referenced task order Statement of Work paragraph 5.4 (Environmental Planning Support). Within the SOW paragraph 5.4, it is stated that Boeing Realty Corporation will be performing property ownership research. Based on several discussions with Custom's and Border Protection (CBP) regarding environmental planning, First American was the title company of choice. Boeing would like to utilize First American for this effort, but the SOW specifically identifies Boeing Realty Corporation. Instead of referencing a specific realty company, we would like to propose that we generalize the reference in the paragraph. The following proposed SOW sentence shall be **revised from**:
