The purpose of this modification is to correct an administrative error in the appropriation data of the Task Order (TO). Funds provided by the underlying Purchase Requisition, 0020035878, of this TO for the Supply and Supply Chain Management (SSCM) effort and later obligated in the Letter Task Order were assigned to Account Assignment K, which is used for general expensed goods/services that do not require tracking. Barrier materials for the SSCM project do require tracking as assets of the US Customs and Border Protection.

14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

This modification will de-obligate funds under Item Number 00020, under which the erroneous Account Assignment was made. Funds will be re-obligated under the subsequent modification P00005, which will segregate the funds into Item Numbers that have the correct Account Assignment, and will permit asset tracking.

The following paragraphs describe the specific actions take with this modification.

1. Line Item 00020 is deleted and funding for the TO reduced as follows:

2. It is the Government's intent to re-obligate \$303,311,455.00 as soon as practical, but not later than August 15, 2008.
