14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of this modification is to de-obligate excess funds in the amount of \$5,123,763.00, from CLINs 0070, 0080, 0090 and 0100, respectively. As a result, CLIN 0070 is reduced by \$4,308,754.60, from \$4,308,754.60 to \$0.00. CLIN 0080 is reduced by \$578,883.61, from \$978,883.61 to \$400,000.00. CLIN 0090 is reduced by \$52,946.00, from \$52,946.00 to \$0.00. CLIN 0100 is reduced by \$183,178.79, from \$783,178.79 to \$600,000.00.

In addition, the total amount of the task order is decreased from \$316,485,486.00 to \$294,536,860.00, a difference of \$21,948,626.00.

All other terms and conditions remain unchanged.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
